As you are currently registered on Homehunt for housing with Ochil View we are really excited to announce that we are working in partnership with another six landlords from around Scotland to deliver a new online Digital Lettings Service called **These Homes** which, will replace the Homehunt system we currently use to allocate and relet our properties.

Why are we moving?

We want to be confident that we understand our customers' needs and aspirations. We need to change our system to ensure we capture this information.

We expect to switch over to These Homes mid-March. We will be in touch with everyone who is registered with us on Homehunt towards the end of February with details about how to get started on These Homes and we will be posting regular updates on our Facebook Page using the hashtag **#TheseHomes**.

Please don't worry if you're also registered with other landlords who will still use Homehunt as your registration with them will not be affected, though you will need to change who your lead landlord is.

The landlords moving from Homehunt to These Homes are Ochil View Housing Association, East Lothian Housing Association, Berwickshire Housing Association, Grampian Housing Association, Castlehill Housing Association and Sanctuary Scotland. Hillcrest Homes will also be joining These Homes.

Please note that if you receive this letter from more than one landlord then this is because you are registered with them on Homehunt.

Our new digital lettings system will look very different to Homehunt but will still work in a similar way, in that you will need to apply for the properties you want to be considered for.
