These Homes - Go Live Date

We are excited to be working in partnership with another six landlords from around Scotland to deliver a new online Digital Lettings Service – **These Homes** which will replace the Homehunt system we currently use to allocate and relet our properties.

We will be closing down Homehunt on **Friday 19th March 2021** and switching over to These Homes on **Monday 22nd March 2021**. You will no longer have access to Homehunt unless you are also registered with Eildon or Link Housing Associations, in which case your Lead Landlord status will automatically switch to one of them on that date.

What you need to do

- You will need to register with These Homes from Monday 22nd March 2021 by going to www.thesehomes.com and completing an online application. Please make sure you give yourself plenty of time to complete all the sections, as making sure all the relevant information is filled in will make finding your ideal home much easier
- You will need your Homehunt registration number: «**Reference**». This is so you can keep your original registration date and means that we can transfer any priority on your Homehunt account to your new These Homes account
- **You must register by 16 April 2021 to avoid losing your original registration date and Priority Pass award date**

What Happens Next

Once you have registered with These Homes, we will contact you to confirm your

application and to ask for any further information if needed. We would normally try to do this within a couple of days but we are expecting over 2,500 applicants to register around the same time so it may take us a little longer – please bear with us.

We will stop advertising homes on Homehunt before 19 March 2021 and will resume advertising on These Homes from 16 April 2021. **If you do not register by the 16th April 2021 you will lose your original registration date. This could affect when you may be offered a property with us.**
